Terms and Conditions of Affiliation

This Non-Permanent Affiliation is granted subject to strict compliance with the following mandatory conditions:

1. The institution shall strictly adhere to all rules, regulations, and guidelines issued by the NCTE (including the NCTE Amendment Regulations, 2021), University Grants Commission (UGC), State Government, and Hemchand Yadav Vishwavidyalaya, Durg from time to time.
2. The institution must recruit qualified teaching faculty and a Principal strictly as per NCTE and UGC qualifications under Statute 28 of the University.
3. The institute must maintain adequate infrastructural, instructional, library, and laboratory facilities specific to the dual-degree curriculum (Liberal Arts, Science subjects, and Education pedagogy) as prescribed under ITEP guidelines.
4. Admissions to the ITEP B.A. B.Ed. and B.Sc. B.Ed. courses shall be made strictly through the National Common Entrance Test (NCET) conducted by NTA, and admissions shall not exceed the sanctioned intake.
5. Tuition and other fees must be charged strictly according to the fee structure approved by the State Fee Regulatory Committee. No capitation fee or donation shall be charged.
6. This affiliation letter will be based on the latest affiliation letter approved by NCTE and if any matter of the college is lying with court than the decision of honourable High Court will be applicable.
7. Any violation of NCTE regulations, UGC guidelines, State Government rules, or University Ordinances will result in the immediate withdrawal of this provisional affiliation without further notice, at the sole risk and responsibility of the management.
8. If there is any modification regarding subjects/classes/seat no. in this affiliation letter, then colleges should compulsorily contact University within **10 days** from the date of release of letter along with documentary proof.
